What takes place if a neighbor does not reply to an event wall notification?

Act 1996, if an adjacent owner does not reply to a Party Wall Notification within 2 week, the regulation considers this a regarded dissent. This automatically triggers a disagreement, also if the neighbour has not officially objected. This is not a dead end - it in fact instates the conflict resolution procedure.

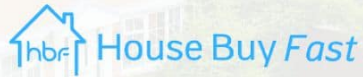
