

If a dog bit you in the Atlanta area, Georgia works differently than people expect.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

Local ordinance violations are usually easier to establish, which is why the first questions are about where the dog was and whether a complaint was ever filed.

Records disappear quickly here. Prior complaints and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
