

Fort Worth has always had a practical streak. People here tend to value a fair deal, a clean closing, and a process that does not waste time. That mentality shows up clearly in real estate right now. Repairs are the quiet dealbreaker

For many Fort Worth sellers, repairs are what turn an ordinary listing into a headache. Cosmetic work is one thing. A broken HVAC system in a Texas summer, foundation concerns, roof damage after a storm, or aging plumbing is something else entirely. These are not the kind of issues homeowners want to solve just to keep a deal alive.

That means the seller may be expected to address repairs before closing or negotiate credits after inspection. Both options cost money. Both options can delay the sale. The buyer does not pressure the seller into signing before questions are answered.

The timeline is realistic and aligned with title and closing requirements.

The contract does not hide extra fees or vague conditions.
