

Losing someone in a preventable crash is not a legal problem first. It becomes one later, usually when the bills arrive or an insurer calls.

Georgia handles a death case [atlanta personal injury attorney](#) differently than most people expect. Two separate claims generally exist. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. Georgia law sets an order for who may bring that first claim. It generally begins with a surviving spouse, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also disappears, particularly where a commercial vehicle or a business is involved.
