

If a dog bit you in Atlanta, the rules may not be what you [truck accident attorney](#) assume.

In some places an owner is liable automatically. That is not the Georgia rule. The question is normally whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

This evidence does not last. County records and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
