

When someone is shocked or burned on a job site in Georgia, several companies may share responsibility.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it bars a suit against your employer. It does not bar a claim against a third party whose conduct created the hazard.

That third party claim is usually where the real recovery sits, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, and none of that is available just for the [local car wreck lawyer](#) asking.
