

What the Anion Gap Measures

The **anion gap** is a derived value that assists clinicians interpret **serum electrolytes** and evaluate an **acid-base disorder**. It is typically derived from the measured concentrations of **sodium**, **chloride**, and **bicarbonate**. Because it contrasts major measured ions with the ions not routinely reported, it gives valuable insight into **acid-base balance** and possible metabolic problems.

In plain terms, the anion gap represents the difference between the main positively charged and negatively charged ions in the blood. Sodium is the principal measured cation in most panels, while chloride and bicarbonate account for much of the measured anions. Medication and toxin exposure also are important. **Lithium toxicity** can lower the anion gap because lithium is an unmeasured cation. In the same way, **bromide** exposure may create misleading chloride readings in some

assays, which can distort the calculation and create a spurious low or even negative result. These are typical examples of how **lab artifact** and chemistry interference can resemble disease.

Not all low number means a dangerous condition. Some low results occur because of specimen issues, instrument variation, or unusual sample composition.
