

A truck wreck is not a car wreck. A fully loaded truck can outweigh your car many times over, and people tend to get hurt much worse.

The difference starts in the first hours. The trucking company often sends its own people to the scene before the road is even clear, before you are out of the hospital. They start protecting the company immediately.

More than one company can be responsible. The trucking company, a maintenance contractor, a freight broker, or whoever loaded the trailer can each share it. Each of those is its own question with its own evidence.

A commercial truck generates paperwork a passenger car never will: hours of service logs, engine and braking data, maintenance and inspection files, and the driver qualification file. A lot of it can be purged in the ordinary course of business, so a preservation demand is typically sent right away.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
