

An **anion gap calculator** is a useful **diagnostic tool** for calculating the distance between measured cation levels and measured anions in a **serum chemistry** or **metabolic panel**. This standard formula includes **sodium**, **potassium**, **chloride**, and **bicarbonate**:

Anion gap = (Sodium + Potassium) – (Chloride + Bicarbonate)

Some formulas leave out potassium and use:

Anion gap = Sodium – (Chloride + Bicarbonate)

Each formula is used in clinical practice. Including **potassium** produces the numerical result slightly higher, but many clinicians favor the simpler version because potassium contributes less to the total and may not significantly change the decision-making process. What matters is knowing which formula your lab or clinician uses before comparing the result to a **reference range**.

Here is the practical role of each component:

- **Sodium** serves as the main measured cation in the calculation.
- **Potassium** is a smaller measured cation that may be included in some formulas.
- **Chloride** is the major measured anion that often rises when bicarbonate falls.
- **Bicarbonate** indicates buffer status and is central to interpreting acid-base balance.

The interplay of these values helps identify an **anion difference** that suggests acid retention, bicarbonate loss, or shifts in measured electrolytes. A proper calculation depends on accurate sodium level, potassium level, chloride level, and serum bicarbonate results from the same sample whenever possible.

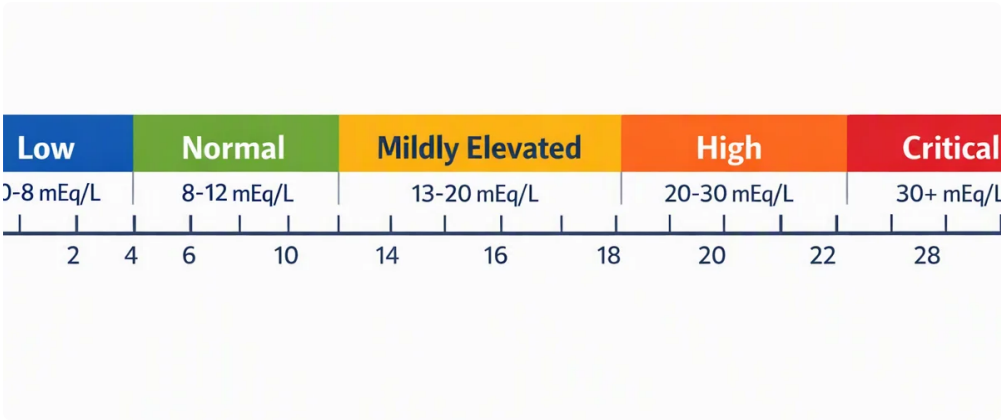

The **normal anion gap** typically falls within a laboratory-specific **normal range**, and the exact cutoff depends on whether potassium is included and how the analyzer reports bicarbonate and chloride. In most settings, the standard range is comparatively narrow, but your local laboratory may define slightly different **normal values**.

A **increased anion gap** means there are extra unmeasured acids or unmeasured ions than expected.
