

When someone is shocked or burned on a job site in Atlanta, several companies may share responsibility.

Workers compensation pays medical bills and a portion **truck accident lawyer** of lost income when the injury is work related, and it bars a suit against your employer. It does not bar a claim against a third party whose conduct created the hazard.

That third party claim is usually where the real recovery sits, since comp covers none of the human loss and only part of the financial one.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
