How does sealed-system failure create unwarranted liability on older appliances?

Once a seal fails or refrigerant leaks, the entire system must be recharged or replaced. Here is where no-recourse risk becomes acute: a recharge performed on a 12-year-old refrigerator carries no guarantee that the seal will hold for even one month. But here is the redo exposure: if the compressor is repaired, not replaced, and the connected condenser or evaporator fails six months later, you now face a second \$800 to \$1,200 bill with no recourse. The 50-50 rule assumes the repair will hold; it does not account for unwarranted liability on cascading failures. 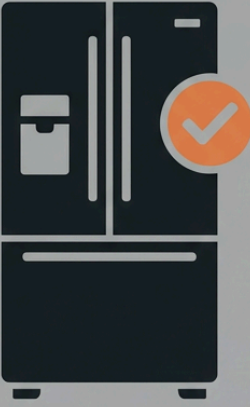
How do Sacramento's hot summers accelerate unwarranted failure risk?

Sacramento summers exceed 100°F, and older refrigerators work harder to maintain temperature in high-heat conditions. This thermal stress accelerates compressor wear and condenser coil degradation. When repair work is performed on a unit already stressed by years of summer operation, the timeline to next failure compresses. A sealed-system recharge that might last two years on a newer appliance in a mild climate may last only three months on a 13-year-old refrigerator in Sacramento's Central Valley heat. Residents close to neighborhoods like Midtown depend on reliable cooling year-round, and an unwarranted repair that fails mid-summer leaves you without recourse during the season when you need the appliance most. What happens when warranty expiration leaves repair costs entirely on you?

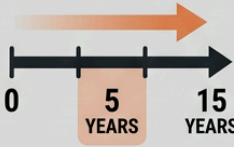
