

If you or your child were bitten in Georgia, the rules may not be what you assume.

In some places an owner is liable automatically. That is not the Georgia rule. The claim generally turns on whether [click here](#) the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

Local ordinance violations are usually easier to establish, which is why the first questions are about where the dog was and whether anyone contacted animal control.

These records fade fast. Animal control files and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
