

Losing someone in a preventable crash is not a legal problem first. It becomes one later, often when the bills arrive or an adjuster calls.

Georgia handles a death case differently than most people expect. There are generally two separate claims. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Georgia law sets an order for who may bring that first claim. It generally begins with a surviving spouse, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or [atlanta personal injury attorney](#) a state agency can require written notice long before a lawsuit <https://thoughtminty.com/s/ItYjKotYes90XghAMdbcX> is due. Evidence also thins out, especially when a company vehicle or a business is involved.
