

If you or your child were bitten around Atlanta, Georgia works differently than people expect.

In some places an owner is liable automatically. Georgia does not work that way. Usually it comes down to whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and witnesses on the **experienced personal injury lawyer** same street tend to stay quiet.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

This evidence does not last. County records and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
