

If you were hurt by electrical contact around Atlanta, the answer is rarely a single company.

The claim against the other company is normally where the meaningful money is, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Working out who was responsible means getting the contracts, the **personal injury wrongful death lawyer** safety plan and the daily logs, and none of that is available just for the asking.
