Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by [Atlanta injury claims lawyer](#) asking.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
