

If you or your child were bitten in Georgia, the rules may not be what you assume.

Some states hold the owner responsible no matter what. Georgia does **Helpful resources** not work that way. The question is normally whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

Records disappear quickly here. Animal control files and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.
