Sometimes it fits. Frequently the driver simply did not see the motorcycle and turned across it.

Reconstruction matters more here than testimony, since the story is doubted before it is told. Damage patterns carry more weight than either version of events.

Injury severity cuts both ways. A rider has no structure around them, so the same impact **truck accident lawyer** produces far worse injuries. The defense response is often to argue the rider accepted that risk by riding at all.
