

If an electrical injury happened at work in Atlanta, several companies may share responsibility.

A site has an owner, the general contractor, the electrical subcontractor, sometimes the utility, sometimes an equipment manufacturer, and sometimes a labor supplier. Each carries its own coverage and its own reason to blame someone else.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it bars a suit against your employer. It does not bar a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, since comp covers none of the human loss and only part of the financial one.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.
